Pennsylvania's participation in federal projects:

ACEP.ALE (originally FRPP)

-Since 1996, 42,208 acres preserved, totaling over \$39 million in funding

2018 RCPP Implementing BMPs and CNMPs on PA Preserved Farms

-Awarded \$6.3 million. 38 different BMPs installed (\$4 million in funding), and 525 acres preserved

2019 RCPP Kittatinny Ridge Conservation Landscape

-Awarded \$10 million with 9 partners, To date, over 2,607 acres preserved totaling \$3.95 million


2022 RCPP Farmland Preservation and Climate Change Mitigation


-Awarded \$7.85 million with 4 partners. To date, \$855,000 in climate-smart practices. Plus, \$2.1 million in supporting BMPs


